Privacy and Cookies Policy

This statement tells you how CHANGE will collect and process your personal data when you access this website. The policy applies only to information collected through our website and not to information collected offline.

What information do we collect?

We collect information from you when you register on our site, place an order, subscribe to our newsletter, respond to a survey or fill out a form.

What do we use your information for?

How do we protect your information?

We implement a variety of security measures to maintain the safety of your personal information when you place an order or enter, submit, or access your personal information.

We offer the use of a secure server. All supplied sensitive/credit information is transmitted via Secure Socket Layer (SSL) technology and then encrypted into our payment gateway providers database only to be accessible by those who are authorised with special access rights to such systems and who are required to keep the information confidential.

At no time does CHANGE see your credit card or bank details. After a transaction, your private information (credit or debit card details, etc) will not be stored on our servers.

Do we use cookies?

Yes. We use cookies to help us remember and process the items in your shopping cart and when you log-in as a customer. Cookies are small files that a website, or its service provider, transfers to your computer's hard drive through your web browser (if you allow it) that enables the site or service provider's systems to recognise your browser and capture and remember certain information.
